In accordance with the Order of the Office of the Governor issued March 16, 2020, the City Council of the City of Jamaica Beach, Texas, will conduct a financial workshop and public hearing concerning the 2022 FY Budget and Tax Rate Proposal followed by the regular meeting scheduled at **5:30 p.m. on Monday, August 16, 2021** in the City Hall Council Chambers, located at 16628 San Luis Pass Road, in part by telephone conference in order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") to slow the spread of the Coronavirus (COVID-19). **The meeting is also open for those interested in attending the meeting in person.**

PUBLIC COMMENTS *At this time, any person with city-related business may speak to the Council. In compliance with the Texas Open Meetings Act, if a member of the public comments or inquires about a subject that is not specifically identified on the agenda, a member of council or a staff member may only respond by giving a statement of specific factual information or by reciting existing policy. The City Council may not deliberate or vote on the matter. (LIMITED TO THREE (3) MINUTES PER PERSON)*

PUBLIC HEARING At this time, any person may speak to Council concerning the proposed tax rates for 2022. To express concerns each interested person must sign up at the meeting, or notify the City Secretary prior to the meeting by calling City Hall at 409-737-1142.
