

AN ORDINANCE ESTABLISHING A PRIMA FACIE SPEED LIMIT OF 30 MILES PER HOUR ON ALL STREETS NORTH OF SAN LUIS PASS ROAD, 10 MILES PER HOUR ON ALL STREETS AND BEACHES SOUTH OF SAN LUIS PASS ROAD, 35 MILES PER HOUR ON SAN LUIS PASS ROAD, AND 5 MILES PER HOUR ON ALL CANALS LOCATED WITHIN THE CORPORATE LIMITS OF THE VILLAGE OF JAMAICA BEACH, TEXAS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, by virtue of the power vested in the VILLAGE OF JAMAICA BEACH, TEXAS, by Article 6701d, Section 169, V.T.C.S., Article 5415d V.T.C.S. and based upon an engineering and traffic investigation it has been determined by the Village Council of the VILLAGE OF JAMAICA BEACH, TEXAS, that the reasonable and safe prima facie speed limit on all streets situated within the VILLAGE OF JAMAICA BEACH North of San Luis Pass Road should be 30 miles per hour, and on all streets including the beach situated within the Village limits of the VILLAGE OF JAMAICA BEACH South of San Luis Pass Road should be 10 miles per hour, and on San Luis Pass Road situated within the Village limits of the VILLAGE OF JAMAICA BEACH should be 35 miles per hour, and on all canals located within the Village limits of the VILLAGE OF JAMAICA BEACH should be 5 miles per hour, said speed limits to become effective when appropriate signs giving notice thereof are erected on said streets, beach, and canals. Penalties for the violation of this statute will be assessed under Ordinance No. 76- 6. NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF JAMAICA BEACH, TEXAS:

SECTION 1. That the above speed limits are hereby adopted and the hereinbefore recited ordinance be enacted as 76- 1 of the ordinances of the VILLAGE OF JAMAICA BEACH, TEXAS.

SECTION 2. All ordinances or parts of ordinances in conflict with provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION 3. That this ordinance shall be and become effective from and after its adoption and publication as required by law.
