

ORDINANCE 77-11

AN ORDINANCE PROHIBITING MINORS FROM REMAINING ON OR IN ANY PUBLIC PLACE WITHIN THE CONFINES OF THE CORPORATE LIMITS OF THE VILLAGE OF JAMAICA BEACH, TEXAS BETWEEN THE HOURS OF 12:00 MIDDNIGHT AND 5:00 A.M. AND PROVIDING PENALTIES FOR VIOLATION OF THIS ORDINANCE.

BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF  
JAMAICA BEACH, TEXAS:

SECTION 1. It shall be unlawful for any child under the age of eighteen years to be and remain on or in any public place located within the corporate limits of the Village of Jamaica Beach between the hours of Twelve (12) O'clock midnight and Five (5) O'clock A.M., unless such child is accompanied by his parent or guardian or some other adult person or there exists a reasonable necessity therefore.

SECTION 2. It shall be unlawful for any parent, guardian or other person having legal care and custody of such child, to allow or permit any such child, ward or other person under such age, while in his legal custody, to go or be on or in any public place in the village within the time and or prohibited in this Ordinance.


SECTION 3. The violation contained in this Ordinance shall be cumulative of any other offense, whether said other offense is within the purview of state law or Village Ordinance, which occurs.


SECTION 4. Penalties for the violation of any act prohibited by this Ordinance will be assessed under Ordinance 76-6 as amended by Ordinance 77-1.

SECTION 5. That the hereinbefore recited Ordinance be enacted as 77-11 of the Ordinances of the Village of Jamaica Beach, Texas.

SECTION 6. That this Ordinance shall be and become effective from and after its adoption and publication as required by law.
