## SWIMMING POOL SEASON PASS APPLICATION FOR VACATION RENTAL PROPERTY

THIS SWIMMING POOL SEASON PASS MEMBERSHIP IS FOR VACATION RENTAL PROPERTIES ONLY. TO QUALIFY FOR MEMBERSHIP, APPLICANT MUST BE ACTIVELY REPORTING AND PAYING HOTEL OCCUPANCY TAXES TO THE CITY OF JAMAICA BEACH FOR THE PROPERTY ADDRESS INDICATED ON THE APPLICATION. **THE VACATION RENTAL PROPERTY SEASON PASS MEMBERSHIP FEE IS \$300.00.**

PASS WILL ALLOW ADMISSION, OF NO MORE THAN 4 "ELIGIBLE GUESTS" PER DAY, TO THE CITY OF JAMAICA BEACH SWIMMING POOL. PASS IS VALID ON ANY PUBLIC OPERATING DAY DURING THE 2019 SEASON. PASS MUST BE PRESENTED TO POOL ATTENDANT UPON ENTRY. THERE WILL BE A \$10.00 FEE TO REPLACE A PASS. UNAUTHORIZED USE, INCLUDING DUPLICATION, OF PASS IS PROHIBITED AND WILL RESULT IN TERMINATION OF MEMBERSHIP. ALL PASSES ARE NON-REFUNDABLE. PLEASE READ THE ADDITIONAL GUIDELINES, IMPORTANT INFORMATION, RISKS AND WAIVER PRINTED ON THE BACK OF THIS APPLICATION BEFORE SIGNING APPLICATION. PRICES, SCHEDULES AND POLICIES ARE SUBJECT TO CHANGE WITHOUT NOTICE.

**Additional Guidelines:** PASS IS VALID FOR NO MORE THAN 4 ELIGIBLE GUESTS PER DAY (PASS IS NON-TRANSFERABLE WITHIN THE SAME DAY). **To clarify:** the pass allows unlimited entry for the day to the same 4 individuals that originally used the pass; pass cannot be used by 4 guests then transferred to 4 different guests to use within the same day. Additional guests will be required to pay the \$5.00 per person/per day entry fee. To be considered an "Eligible Guest" the individual(s) must be listed as a guest in the short-term rental contract. Homeowners may not purchase a vacation rental property season pass for personal use and/or distribution (sharing). A separate individual season pass must be purchased for personal use. Unauthorized use, including personal use, of vacation rental property season pass is prohibited and will result in termination of membership. Season pass memberships for vacation rental properties are limited to two (2) passes per property. ALL PASSES ARE NON-REFUNDABLE.

**Important Information:** The City of Jamaica Beach "City" is committed to providing safe aquatic facilities and holds the safety of all users in high regard. The City continually strives to reduce such risks and insists that all members and guests follow the City's pool rules and staff instructions that are intended to protect participant safety. However, individuals engaged in aquatic activities must recognize that there is an inherent risk of injury. You are solely responsible for determining if you or your minor child/ward is physically fit and/or adequately skilled for the use and/or activities associated with this pool pass. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical/aquatic activity.

**Warning of Risk:** Swimming and other aquatic activities challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including but not limited to drowning, head/brain injury, and cervical spine injury. Understandably, not all hazards and dangers can be foreseen. The very nature of swimming and aquatic activities are hazardous and risky, including but not limited to fatigue and overexertion, poor swimming skills, failing to avoid dangerous areas, failure of lifeguards to locate victims and/or delay in emergency response time, horseplay, diving or cannon-balling into shallow water and striking the bottom or side of the pool or waterslide, poor supervision or instruction, lack of conditioning, becoming disoriented, striking other swimmers, defective or inadequate equipment, striking one's head on the bottom when using a diving block, slipping or falling on the deck or within the locker facility, chemical exposure and all other circumstances inherent to aquatic activities and aquatic facilities. In this regard, it must be recognized that it is impossible for the City to guarantee absolute safety.

**Waiver and Release of All Claims and Assumption of Risk:** Please read this carefully and be aware that by signing the Swimming Pool Season Pass Application for your vacation rental property guests to enter, use and/or participate in activities at the City of Jamaica Beach pool and aquatic facilities located at 16721-A Jolly Roger, Jamaica Beach, TX 77554, you agrees to waive, release, defend, indemnify, and hold harmless the City of Jamaica Beach, including its officials, managers, agents, volunteers and employees (collectively "the released parties") from and against any and all claims, demands, actions, and liabilities for personal injury or property damage directly arising out of, resulting from or in connection with or relating to the membership that is subject to this application regardless of whether there are damages or injuries. Applicant agrees to assume liability for all guests and releases the City of Jamaica Beach from all responsibilities. I have read and fully understand the above important information, warning of risk, assumption of risk, and waiver and release of all claims.
